

**ADMINISTRATION OF THE COMPUTER-BASED ENGLISH PROFICIENCY TEST
FOR TEACHER APPLICANTS FOR SCHOOL YEAR 2021-2022**

To: OIC-Assistant Schools Division Superintendents, SGOD Chief, CID Chief, Education Program Supervisors, Public Schools District Supervisors, Education Program Specialists, School Heads, District and School ICT Coordinators, and All Concerned

1. With reference to **Division Memoranda Numbers 025 and 030, S. 2021 re: Recruitment, Selection, Evaluation and Ranking of Teacher-Aplicants for SY 2021-2022 (BATCH 1) and Corrigendum to Division Memorandum No. 025, S. 2021**, this Office announces the administration of the **Computer-Based English Proficiency Test (CB-EPT) for Teacher-Aplicants for School Year 2021-2022**. The test will be administered on **March 15-19, 2021** in different Testing Centers.
2. For proper guidance, the following are **required** to take this year's CB-EPT:
 - a. Applicants who have not taken the proficiency test previously; and
 - b. Applicants who took the test in **February 10, 2019** at **Quezon National High School** who have not been appointed to a permanent position.
3. On the other hand, the following may **opt not to** take this year's CB-EPT:
 - a. Applicants who took the **paper-and-pencil EPT** administered on **September 1, 2019** at **Quezon National High School**; and
 - b. Applicants who took the **computer-based EPT** administered last **September 28 to October 2, 2020** and **October 14-16, 2020** who have not been appointed to a permanent position;
